- Written a custom application to analyze our monthly financials and highlight items that are over-budget. In conjunction with this I have worked with staff to seasonalize our budget so (for example) our expenses for lifeguards only show in the budget months we actually <u>have</u> lifeguards;
- Joined the Community Association Institute ("CAI") and attended seminars to learn about issues common to associations like ours, how to avoid them where possible, and deal with them effectively when they do occur;
- Been actively involved with the yearly Reserve Study which helps our association plan for maintenance/repair and replacement of major components of our association common area.
